For the foreseeable future you will need to have an annual waiver on file to attend any SCCA function. Please see below for a note from our Chief Registrar.

ACTIONS MUST BE TAKEN BY YOU BELOW. PLEASE READ ON.

As you are aware, we are in very sensitive times, because of the COVID 19 issue; we need to set up the following procedures for this event at Motorsports Ranch Speedway in Angleton, Texas. Your safety is our first priority and we ask for your patience and appreciate your understanding.

You will not be allowed to enter the track until you get a completed package from our Chief Registrar.

COVID-19 UPDATES for Houston Region SCCA FUN IN THE SUN

There will be no REGISTRATION at the track, we are requiring everyone to

complete all registration On-Line. This will require you to take a few more steps below. These steps will take time and your immediate response to them is needed, so that we can all go race.

1. As a driver you must have a current SCCA Full Competition License and Membership.
2. EVERYONE must have an Adult Annual Waiver (AAW). On file with Regional and National offices.
3. IT MUST be filled out and submitted to regional register before getting to the track.

We are attaching the AAW (Adult Annual Waiver) with this email so that you may sign and have notarized. **Only a 'Color' scanned original is acceptable and can be emailed to both addresses below.**

MSR Houston – ANGLETON, TEXAS Additional Notes (COVID-19)

- A. Bring your own pen, for signing the MSRH waiver.
- B. Maintain a respectful distance from others.
- C. Select a paddock area with a safe distance from others.
- D. Avoid personal contact with others.
- E. Bring your own supply of water and food. None will be provided.
- F. All enclosed areas are closed except the front office.
- G. There will be no after race gathering on Saturday after the race.
- H. Driver's Lounge will be closed.
- I. You will still be required to sign a Track Waiver for MSR Angleton at Gate Entrance.
