**ADDENDUM A TO SUPPLEMENTAL REGULATIONS VERSION 16 DATED JUNE 11, 2020**

**ALL RULES AND REGULATIONS THAT ARE COVID-19 RELATED ARE NOT PROTESTABLE.**

Items contained in this ADDENDUM A are current as of July 2, 2020. The original regulation is listed in **RED** below. The change or revision to the original regulation is listed in **BLACK**. If you do not see a change listed in this ADDENDUM A, then the regulation remains the same as stated in the Supplemental Regulations, Version 16 dated June 11, 2020.

**Upon entry to Mid-Ohio Sports Car Course everyone must have a medical health assessment form filled out and signed (assessment form is posted on MSR). We ask that you fill the form out prior to your arrival. Mid-Ohio will not have copies at the gate. There might be a very limited supply at registration. You are strongly encouraged to download the copy posted in MSR. The completed form shall be given to the security guard at Gate #3. You will only need to complete the form the first time you enter the facility for the event.**

There been many questions to this question “Have you come into close contact (within 6 feet) in the past 14 days with someone who has been diagnosed with COVID – 19?” A yes answer to this question will not in its self, cause you not to be allowed on the property. A yes answer to this question **will** require further medical history being taken by a medical professional.

**Temperatures will be taken each time for entry into the facility. If you leave and return you will have your temperature taken again. Anyone showing signs/symptoms or has a fever will not be able to enter the facility under any circumstance.**

If you record a temperature above 100.4, you will be pulled off to the side and 2<sup>nd</sup> check will be done in approximately 5 minutes. If the 2<sup>nd</sup> check is above 100.4, **you & anyone in your vehicle** will be asked to leave the property.

**All participants must wear a mask at all times during their visit unless you are wearing a driving helmet for on track activity. You may temporary remove the mask to eat, drink or smoke.**

All participants must wear a mask under the following conditions:

- A. In a building or structure (this includes garages and restrooms). You do not have to wear a mask while showering.
- B. In any hot area where social distancing is not possible.

**Currently Ohio defines social distancing as a distance of not less than 6 feet and no groups greater than 10 people.**

**Spectators are not permitted for the event. We ask that only those participating in the event attend and that all non-essential family & friends remain at home.**

**While SVRA/Trans Am weekend had a limited number of approved spectators, this was a one-off event that the State of Ohio and Morrow County allowed Mid-Ohio to have.**

**Section I, Regulation G**

**PASSES: Each car will receive three (3) passes, including the driver and two (2) crew. Additional passes cannot be purchased. Spectators are not permitted for your event. We ask that only those participating in the event attend and that all non-essential family & friends remain at home.**



Based on current entries, we have increased the crew size to 3. That means 4 passes, 1 driver and 3 crew. For club weekend, Mid-Ohio has a maximum number of people that can be on the property. This includes participants and staff.

## Section VI, Regulation O

**At the current time, the infield will be closed and there WILL BE no spectating in the infield.**

At the current time, there will be limited access to the infield. As always, grandstands are CLOSED.

## ADDITIONAL INFORMATION SINCE SUPPLEMENTAL REGULATIONS 16 WAS POSTED

1. Due to the tower (5 story) being closed for the weekend, OVR is encouraging all participants to bring an FM radio and listen 90.3 for all race announcements.
2. Wrist bands (1 for the event and 1 for the Mid-Ohio Medical Assessment Form) must be visible and must be shown upon request from a race official and/or Mid-Ohio staff member.
3. Water at Tech. Will be available, however do not come up and get the water, it will be brought to you.
4. There will be no community coolers. You will need to bring your own cooler.
5. Worker Camp Ground is open. Please Social Distance when setting up your camping spot.
6. Driver Information will be at the base of the tower. Practice Social Distancing when at driver information.
